# Update on the management of the NCRC

Three organizations that use this building (the CAC, Three Rivers, and the Senior Center) are in the process of taking over the management of the NCRC. These three have formed a new non-profit named the NCRC Corp. The NCRC Corp will hire a management company to oversee the maintenance of the building; the City will still own the building.

Using financial information from the City, an operating budget for the NCRC has been developed, structured as the building is financed today. The difference is that rather than the City receiving payments from the organizations using

the building and paying the expenses, the property management company will receive the lease payments and pay expenses. It is planned that the Senior Center and the other nonprofits will not pay any more than they are paying now for the lease payments.

So why do the partner organizations want to manage the building? The City Administrator has made it very clear, that the desired outcome for the City is that ownership of the NCRC will be transferred to one or more of the organizations at the end of the three year contract. During the three years that the NCRC Corp manages, the partners will have a better understanding of the operating costs for the building and if there are ways to reduce the costs. The partners will be involved in the management of the

building to assure that the maintenance of the facilities is done efficiently and in a timely manner. For the Senior Center staff and Board of Directors, we will have a keener understanding of the facility operations, especially for the pool, heating systems, etc. By the end of the term of the management contract, the NCRC Core Group will determine if it is feasible to transfer ownership of the building, if this is a next step for the organizations, and if the reasons are compelling enough to take this next step.

## The Last Dance

A Conversation with Rev.
Duane Everson

Category: Non-Fiction

Rev. Duane Everson served forty five years in Minnesota congregations as a Lutheran Pastor (Evangelical Lutheran Church in America). He is a graduate of Luther College in Decorah, Iowa, Westburg Seminary in Dubuque, Iowa, and was ordained in 1967. Rev. Everson served as a Pastor at St. Peter's Church in Northfield for 12 years, and officiated for the funeral of a friend that follows.

Steven James Beto (Sjb): The funeral was created to be something quite unique.

Rev. Duane Everson (RDE): Throughout the ceremony, I

played on a theme. I remembered a song with a line: If you get a chance, don't sit it out, dance. During the homily and the entire service, I repeated: If you get a chance, don't sit it out, dance, and here, I was picking up the notes that in life, Dan was not a wall-flower. He didn't sit it out; not Dan. He got on the dance floor and he danced a big dance all through his life, and he had a positive, wonderful effect on a lot of people. If you get a chance, don't sit it out, dance.

During the Benediction at the end of the service, I repeated the phrase to emphasis the theme: *The Last Dance* and I sat down to listen to the music coming from the balcony—string music, nice and upbeat music, and a gentleman stood up and asked Dan's sister to dance, and together they began dancing in the aisle arm in

arm, then I got up and asked Dan's ex-wife, Gretchen, to dance, and within thirty seconds, Steve, the entire congregation—and this place was packed—is dancing. Everyone in the congregation was dancing! They couldn't get everyone in the aisle, in the chancel, so they were dancing between the pews! Completely spontaneous—I was just in awe. It was fun. It was a fun day. My first thought was, what would the old preachers of a hundred years ago say?

Sjb: They were dancing that day, Reverend.

RDE: I hope so. We attend funerals, you know, not because someone has died, but because someone has lived.

# Make Headlines in January

"The universe is made of stories, not atoms," says author Muriel Rukeyser — and there are thousands and thousands of amazing stories at the Northfield Senior Center. We'll have the opportunity to share some of them with St. Olaf students in January, when the NSC will serve as a resource for a month-long journalistic writing class being taught by Jan Hill.

Jan's students are going to be assigned to complete (1) two news stories, which can be of any sort as long as students can apply the 5 W's in a lead and find a news peg to give the story currency if it isn't new this week; (2) speech or meeting coverage;

(3) arts stories, either reviews or features; and (4) some sort of personality profile, which will give reporters a choice of a narrative or an interview format. We've got all of that and in spades – colorful and interesting experiences, active lives, and expertise on a wide variety of subjects, from agriculture and art to zoology and zumba.

The students will come to the center three Fridays in January to scout for stories and/or arrange to interview people at the NSC there or in a location of mutual convenience. Nancy Ashmore, vice president of the NSC board, will prep them for the experience during a class presentation on the center, its history, and its demographics and will help connect them to people at the center who

can speak to particular topics they may be interested in.

In addition to the opportunity to help out Jan and her students, this project offers the possibility of being able to use many of the resulting articles in the NSC newsletter, on the website, and as the basis for pieces that we'll submit to the Northfield News and other media in order to raise the visibility of the center.

# AARP Rolls Out New Smart Driver Course

After nearly two years of planning, research, volunteer insight, expert input and testing, AARP will roll out its new driving safety courses in January 2014. The renamed

#### "AARP Smart Driver

Course" is designed for the driver over age 50 to help discover how roads, cars, and you may have changed in recent years. The courses teach research-based safety strategies; the links among the driver, vehicle, and road environment; and how awareness increases self-policing behaviors and overall safer driving. Learn the newest safety and advanced features in vehicles and tips for accessing when alternate transportation methods may be the safest option.

According to one of our local AARP volunteer instructors and former high school teacher, George Kinney, "The new version of the AARP Smart Driver Course is *much* improved. He especially likes the new videos that showcase the technology changes in current automobiles and gives us glimpses of even more changes on the way." Led by Daryl Rieck, AARP Driver Safety Deputy State Coordinator, AARP has several trained instructors that teach at the Senior Center. George said," I like teaching because I enjoy meeting people. Many have genuine concern for other drivers and bring very interesting questions to the forefront for discussion."

Completion of this Smart Driver Course qualifies each student over age 55 (sometimes 50) a certificate redeemable for a discount on auto insurance premium for three years. First timers must take the 8-hour course then a refresher course every 3 years to continue the discount. Please check with your insurance agent for age qualifications and renewal details. The cost of this class includes fees paid to AARP for the course.

The meeting was called to order at 3:01 p.m. by Gerry Gengenbach, who welcomed to the board Elizabeth Olson, who succeeds Evelyn Burry who had to resign for health reasons. He announced as well the resignation of Eve Webster, who is assuming care responsibilities for a family member that will make it difficult to attend meetings.

**Action:** The agenda was approved.

Action: Motion and second to approve the September 26, 2013, board minutes. Carried.

# TREASURER REPORT Financial Reports

Tom Brawley reported on the financial statement, noting that there have been no material changes since last month and that expenditures and income are close to target amounts.

# Minutes of the Oct 24 Board Meeting

#### **COMMITTEE REPORTS**

#### **Finance Committee**

Tom Brawley reported with additions by Phil Winter, who noted that stock market activity has been positive lately, but may be unpredictable.

#### **Facilities Committee**

Marv Korman reported. A contractor has been chosen for work in the men's locker room, trees that eventually will shade the back patio have been planted, and room-darkening projects have been completed in the movie room. On the docket for future activity, considering ways to efficiently/ inexpensively increase security in the locker rooms following several recent thefts.

#### Membership Committee

Dottie Hammer reported. The committee recommended a 3% increase for membership dues and an increase in group fees from \$1 to \$2 to help offset a shortfall in the budget proposed for next year. Work is continuing on a number of projects including a banner at the entry, monthly new members' 'get acquainted' gatherings and the 'Welcome' outreach, and a partnership with St. Olaf that will bring students to the center to interview members.

#### **Advancement Committee**

Don Diehl reported. Contributions to the fund drive through September total \$47,000 from 363 donors. The goal is \$70,000, which will be the goal again next year. He noted the formation of a Legacy/ Planned Giving Committee which will review the center's planned giving activities and ways it could be improved. He mentioned as well interest in a fund-raising "walk-a-thon," which will be discussed at greater length in months to come.

#### **Nominating Committee**

Gerry Gengenbach noted the resignation of Eve Webster and asked board members to forward to Don Diehl and Duane Everson the names of potential replacements. He noted that the board was off balance in terms of gender (3 women and 11 men) and that we should also think about skills and experiences that prospects could bring to the organization.

# EXECUTIVE DIRECTOR'S REPORT

Lynne Pederson reported. The staff is preparing for the advent of the Silver and Fit program in January, a second draft of the budget has been prepared which ends the year \$700 in the black, Lynne and Gerry will attend a October 29 seminar sponsored by Minnesota Philanthropy Partners on how to stay connected to donors. Lynne will attend the groundbreaking for the new YMCA in November and has arranged to have its director spend time at the NSC answering concerns about whether the Y will be offering senior programming in competition with the center. [The Y has no plans to do so, but NSC hopes to partner with them on some facilities' use. They have used our pool for several years; we hope to

have access to their walking track.]

#### **OLD BUSINESS**

NCRC—A recommendation was made to the NCRC Core Group to have Bluewater Commercial Real Estate manage the building once arrangements have been finalized with the city. A contract cannot be signed with Bluewater until one is signed with the city, but preparations for the transition are underway. The city is reviewing a draft contract with the NCRC Core Group, which is in the process of being officially constituted. The group will consist of a voting representative of each of the three organizations housed in it (NSC, the CAC, and Three Rivers Community Action), though meetings will be open to other building residents and others.

Action: Motion and second to name "the director of the Northfield Senior Center" as the center's designated representative to the NCRC Core Group. Carried unanimously.

The NCRC Core Group largely will be a "budget-free board," but each of the partners is looking to ante up \$2000 to be used to cover attorney fees and other startup costs.

Action: Motion and second to provide \$2000 from this fiscal year's budget for the purpose of providing startup funds for the NCRC Core Group. Carried unanimously.

In further discussion, the board recommended that Lynne continue to keep NSC members informed via the newsletter and other media

about the progress and outcomes of this process.

**Operations Manual** — Committees are continuing to supply needed information.

Northfield Senior Legacy
Society — Gerry Gengenbach
reported on efforts to begin
the process of ramping up
the center's cultivation of
planned gifts, including
gifts to endowment as
well as designated gifts.
A recent event resulted
in commitments from
seven donors. Volunteers
and staff are researching
various options, including
the formation of an NSC
foundation.

**Action:** Motion and second to encourage and support continuing this effort. Carried unanimously.

#### **NEW BUSINESS**

Patsy Dew reported on work underway to plan a March event at the center to be focused on local sustainability, an outgrowth of NSC's "Conversations that Matter" programming. Organizers want to invite as their keynote speaker Larkin McPhee, a Peabodyand Emmy award-winning director of documentary films, including a PBS special titled Troubled Waters: A Mississippi River Story. Because this will involve soliciting donations from

individuals and groups, something that is restricted by policy, Patsy was seeking board permission for this fundraising.

Action: Motion and second to permit the solicitation of funds for this purpose. Carried unanimously, with the understanding that there will be little overlap with usual donors to the NSC and other plans will be made for keynoting if sufficient funds are not collected.

The next Board meeting date is December 5. The meeting was adjourned at 4:58 p.m.

# IRA Charitable Transfer Is Still OK

**Q.** Is the provision that allows you to make charitable contributions out of retirement accounts still operative?

**A:** Yes. But that law has been extended only through the end of 2013.

Under this provision, those who are 701/2 or older can give away as much as \$100,000 a year from their individual retirement accounts to eligible charities without having to include any of the transfer as part of their gross income. The transfer must be made <u>directly</u> from the IRA to the organization.

Transfers count toward that person's required minimum distribution for the year. This law applies to only IRA's – 401(k) plans are not eligible.

Northfield Senior Citizens, Inc. is a 501(c)(3) nonprofit organization as determined by the IRS and is eligible to receive charitable contributions.

There is a procedure and deadlines to follow. Obtain the form and directions from the IRA broker.
